## FEB MEETING

Ths information was somehow deleted from the motion concerning the equipment changes for working cow horse, boxing and box drive box drive. I included it in the 2023 rulebook.
10. Two rein equipment will be allowed in Working Cow Horse classes, Boxing, box drive box drive and Ranch Horse classes.
a. When using two rein, bosalita may be of any size, constructed of braided rawhide or leather and have a non-metal, flexible core. No iron or foreign substance may be used.
b. The rider must use one hand on the reins. Fingers between the reins will be permitted.
c. Both mecate and bridle reins are to be held in the rein hand.
d. All rules for two rein will follow hackamore and bridle requirements for the respective class.
11. GET DOWN ROPE. In ranch classes, a get-down rope will be allowed with the use of romal reins for the purposes of leading or working on the ground where required in the pattern. The get- down rope may be a neck rope or a neck rope with bosalita that is tied in a manner that will not slide/tighten around the horse's neck. The tail end (lead) of the neck rope may be attached to the front of the saddle with saddle strings or run through the rider's belt loop but should not be tied to the saddle horn.
Re-number rest of rule.

Motion 10-06-2022 - Was never brought forward for a second vote. I have included this in the 2023 rulebook.
741. BOX DRIVE BOX DRIVE

Beginning Fence Work Class Cow Work Guidelines - The goal of this class is to introduce the exhibitor to the "fence work" phase of the cow work.
A. This class may be held for youth, non pro or junior horses. Cross entry will be allowed between this and any other Boxing, Hackamore/Snaffle Bit Working Cow Horse or Working Cow Horse classes.
Motion 13-06-2022 - Was never brought forward for a second vote. I have included this in the $\mathbf{2 0 2 3}$ rulebook.

G. ApHC Versatility Champion A certificate for ApHC Versatility Champion will be awarded when a horse has earned five ROMs, only one of which may be a halter ROM. All ROM's acquired prior to January 1, 1995, shall be counted toward Versatility Champion. Additional halter ROM's (more than 1) acquired in 1995 or later shall not be counted toward Versatility Champion. Beginning with ROM's earned in 2022, a ROM earned in racing may count toward this award.
