

These motions are in draft form (unapproved) and will be finalized, published, and distributed in accordance with Article IV, Section 9 of the Bylaws of the Appaloosa Horse Club and ApHC Rule 70.

Those Board members in attendance for all or part of the 2023 Board of Directors regular meeting on August 30th, 2023, were Dave Parlier, Alison Phillips, Deb Dyer, Dennis Dean, Jordan Kelly, Kama Urton, Ken Johnson, Lori Wunderlich, Ray Burchett, Sean Schembri, and Steve Bennett. Francesco Auriemma was absent. ApHC staff present during this meeting were Kris Byrd, Ceara Maxwell, Keri LeForce, and Lex Smurthwaite.

The meeting was called to order by President, Lori Wunderlich at 4:05 pm PT.

#### Motion 01-8-2023

The 2023 ApHC Board of Directors moves to approve the Rules Committee recommendation of a two-year pilot program for giving Regional Clubs shows the ability to offer Camas Prairie Stump Race, Nez Perce Stake race, Figure 8 stake race and Keyhole into Open (all ages), Jr Horse (5 and under) or Sr Horse (6 and over).

Intent: To gauge the interest the ApHC has in the classes to ultimately be able to point the classes and make them World Show qualifying classes in the future.

Motion made by Dave Parlier, seconded by Sean Schembri. Motion passed unanimously; this is the second vote and will be go into effect.

#### Motion 02-8-2023

The 2023 ApHC Board of Directors moves to send the new definition of Non-Pro as follows back to the rules committee:

#### **Enrollment and Participation Rules for Non-Pro**

Non-Pro defines the individual must meet the definition of a non-pro as follows: Has not engaged in activities that would make him or her a professional. A professional is an individual who:

- A. Accepts remuneration riding, driving, showing and halter, training, schooling, conducting clinics or seminars, or instructing in equitation or horse training or judging.
- B. Performs the above-listed activities for which another person in his or her family or corporation that a member of his or her family controls will receive remuneration.
- C. Performs such activities while accepting remuneration for employment in another capacity for an employer or member of said employer's family who owns, boards, or trains the involved horse.
- D. Rides, drives, or shows in halter in horse shows any horse which he or she or a member of his or her family accepts remuneration for boarding or training.
- E. Accepts prize money in equitation or showmanship classes.
- F. Accepts renumeration in the payment of entry fees, or any expenses for the person or horse of which the non-pro competes by another person other than a non-pro or the non-pros spouse, child, step-child, legal ward, father, mother, step-parent, sister, brother, grandparent, grandchild, or legal guardian.
- G. Holds judging credentials with any other equine organization, or receives remuneration for judging in either the form of a salary, perks or as remuneration for expenses.
- H. Performs the function of a trainer, as defined in rule 151, for another non-related individual.

Motion made by Ken Johnson, seconded by Steve Bennett. Motion passed unanimously; motion is sent back to the rules committee.

#### Motion 03-8-2023

The 2023 ApHC Board of Directors moves to approve that Heritage be a non-qualifying class for the 2023 World Appaloosa Show.

Motion made by Ken Johnson, seconded by Dave Parlier. Motion passed unanimously. This motion has completed its second vote and will be included for the 2023 World Appaloosa Show.

#### Motion 04-8-2023

The 2023 ApHC Board of Directors moves to approve a Non-Pro to ride a two-year-old in a maximum of 3 classes at the World Appaloosa Show.

#### Motion 05-8-2023

The 2023 ApHC Board of Directors moves to approve the addendum to rule 500, from Motion 09-6-2023, as follows:

#### **500. GENERAL RULES FOR JUDGES**

H. 5. ApHC judges shall not have any social contact with exhibitors, owners, trainers or agents 48 hours prior to, during, and 48 hours after completion of judging of any ApHC event/show. This includes personal contact, phone calls, text messages, and all social media. If approached by exhibitors, owners, trainers, or agents before, during, or after an approved ApHC event/show the judge should be polite, professional, and courteous but should make every effort not to engage in social activities. Exhibitors are permitted to ask judges questions pertaining to their tests, when also in the presence of ApHC Staff, Show Management, and/or Ring Stewards.

Motion made by Deb Dyer, seconded by Dave Parlier. Motion passes. This motion has completed its second vote and will be included in the 2024 ApHC Official Rulebook.

#### Motion 06-8-2023

The 2023 ApHC Board of Directors moves to approve the World Qualifying points from Attachment D.

Motion made by Ken Johnson, seconded by Deb Dyer. Motion passed unanimously. This motion has completed its second vote and will be included for the 2024 Official Rule Book.

#### Motion 07-8-2023

The 2023 ApHC Board of Directors moves to approve that Digital Signatures that are received through fax, email of record, or membership portal will be considered acceptable.

Motion made by Dennis Dean, seconded by Sean Schembri. Motion passed unanimously. This is a policy change and does not require a second vote. This will go into effect immediately.

#### Motion 08-8-2023

The 2023 ApHC Board of Directors moves to approve the Increase of Novice points from 20 to 30pts.

Motion made by Ken Johnson, seconded by Deb Dyer. Motion passes unanimously. This motion has completed its second vote and will be included in the 2024 ApHC Official Rulebook.

#### Motion 09-8-2023

The 2023 ApHC Board of Directors moves to approve the rope race, pleasure driving, and cutting classes to be non-qualifying for the 2023 World Appaloosa Show.

#### Motion 10-8-2023

The 2023 ApHC Board of Directors moves to approve the judging application requirements as requested from the Judges Committee as follows:

- 1. **Judge References:** An applicant must have three active ApHC carded judge references that have seen him/her judge. These references can include individuals the applicant has judged or has worked with while judging. Additional reference letters are encouraged. Additional forms will be provided upon request.
- 2. (10) **Show References:** An applicant must have judged at least ten shows (with a minimum of 40 horses) in the last three years. Show reference forms are to be completed by the show managers or show secretaries who must include a show bill and an entry count to be included with the show reference forms. All references must be mailed directly to the ApHC by the reference and not by the judge applicant. Any forms received from the applicant will be returned. The ApHC reserves the right to verify some or all references. Additional forms will be provided upon request.

Motion made by Deb Dyer, seconded by Dave Parlier. Motion passed unanimously.

#### Motion 11-8-2023

The 2023 ApHC Board of Directors moves to recommend that the Judges Committee come up with a list of recommendations for violations that go into our rule book.

#### Motion 12-8-2023

The 2023 ApHC Board of Directors moves to approve the rules changes coming forth from the Rules Committee in Attachment C, with the addendum that b.1. will be kept as "Hoof polish is discouraged."
