

APPALOOSA HORSE CLUB BOARD OF DIRECTORS 2026 DECLARATION OF CANDIDACY



IN 2026 ApHC MEMBERS will elect one representative for a four-year term from each of the following: Territory I, Territory II, Territory III, Territory IV, Territory V, Territory VI, and Territory VII to the ApHC Board of Directors.

Each candidate must file this form along with a candidate resume and a photo on or before **JULY 31, 2026**, in order for his/her name to be printed on the ballot.

Election Policy Procedures: Directors will be elected according to Article IV, Sections 2 and 3 of the ApHC Bylaws. This will be accomplished using this schedule:

JULY 31, 2026—As per Article IV, Section 2.C. of the Bylaws, “In a regular election, the Petition must be submitted on or before the last day of July in the election year...” The affidavit must be signed and notarized before consideration of nomination. Candidates resume and photograph must be included and submitted with the nomination form.

AUGUST 31, 2026—As per Article IV, Section 2.D. of the Bylaws, “Only ApHC members in good standing as of August 31 each year shall be eligible to vote in the regular election that year.

For further rules and guidelines, please refer to the current year’s Official Handbook of the ApHC.

The 2026 ApHC Board of Directors election will be held October 1 through October 31, 2026.
