- 5. Form must be signed & notarized. Please complete using a dark ink pen.
- 6. ApHC retains the right to require additional information and/or photographs before issuing a duplicate certificate.
- 7. If you are the current owner (not recorded with the ApHC) there must be a **Transfer Report Form** completed by the last recorded owner (selling this horse) submitted with this form. Transfer fees apply. **SEE RULE 238 in ApHC handbook for complete rule wording.**
