## Endurance Ride Notes (see Official Handbook of the ApHC for complete rules & fees)

- The horse must be enrolled in the distance program to earn miles

   one-time fee (see rulebook for current fee). The distance fee will increase to \$60 starting April 15, 2025.
- After the first year, there is an annual fee (see rulebook for current fee) to have results recorded in the horse's record. This fee should be included with the first ride report submitted for the horse in the current ride year or paid online in advance of submitting the ride report. The recording fee will increase to \$40 a year starting April 15, 2025.
- Enrollment and payment of enrollment fees and/or payment of annual recording fees can be done online at www.appaloosa.com.
- Both the current recorded owner of the horse and the rider (if different than the owner) must be current ApHC members for mileage to count.
- The horse must receive a completion for mileage to count.
- The ride year is December 1 November 30.
- Ride reports must be received within 30 days of the ride but no later than Dec 15 in order to track current year-end award mileage.
- Endurance rides of 50 miles or more count toward annual medallion, annual high mileage, lifetime 1,000-mile and lifetime Chief Joseph Commemorative awards.
- Limited distance rides of 25 miles or more will only count toward the 250-mile ROM and 500-mile SEA.
- Beginning in 2019, double mileage will not be awarded for overall best condition award.
- There is a late fee of \$75/year to correct mileage records from any prior ride year. Corrected mileage shall not affect any annual or year-end awards earned within a prior ride year.
