Please follow these instructions carefully

1. A notarized Signature Authorization or Lease Agreement forms must be on file with the ApHC prior to acceptance of signature of said agent or lessee.
2. Keep a separate record sheet for each breeding season on each registered stallion used for breeding purposes.
3. Report shall be filed with the ApHC by November 30 of each calendar year. If mailed, must be postmarked on or before November 30 of each calendar year. (June 30 for stallions standing in Southern hemisphere.)
4. **Reports of ApHC stallions may be filed online using the member portal, by email or filed by mail. Payment must be made in full when filing.**
5. **ApHC approved breed stallions that are already listed with the ApHC are accepted by mail, fax or e-mail. Payment must be made in full when filing.**
6. Ask to see the Certificate of Registration of each mare bred. This will assist you in the preparation of this report.
7. Verify that the last recorded owner of the mare is the person contracting the breeding to this stallion.
8. Give exact date(s) bred—If more than one service is given to a mare, please note the different dates.
9. Indicate the breeding method used in the appropriate areas provided on this application.
10. Keep a duplicate copy of this report for your files and future use. Copies requested from the ApHC by the owner will cost \$5 per page.
11. Form must have an original signature from the owner, lessee or authorized agent of the stallion.
12. If the mare is in the process of being registered indicate, “papers applied for” in the Breed & Registration Number column.
13. Stallions or mares that are classified as either N/C, CPO, BSO, BSN,, I#, IN, ID, PC, or registered with an approved breed association must be bred to an Appaloosa with a registration classification of Regular.
14. All stallions by submission of their stallion report must be DNA tested, and the results must be filed with the ApHC. Once DNA results are filed with the ApHC, it is not necessary to repeat such filing, except as requested by the ApHC. If the stallion is registered with an approved breed association and has DNA type on file with said association, the ApHC may obtain permission from the owner to obtain the DNA type from the association by signing a waiver and submitting it to the ApHC along with a DNA waiver filing fee.
15. If the stallion is registered with an approved breed association, a Stallion Breeding Report MUST be filed with the Appaloosa Horse Club. A one-time listing fee is required on stallions and mares not previously listed with the ApHC. A photocopy of both sides of the horse’s current Certificate of Registration must accompany each stallion report. The photocopy must show current ownership and any existing lease agreements.

Fees subject to change -- Make checks or money orders payable to Appaloosa Horse Club, U.S. funds, drawn on U.S. bank. If you wish to pay by credit card, please provide credit card information below. Applications received without required payment will be assessed an Invoicing Fee. Check the current Official Handbook of the ApHC for current fees.
