## **AUTHORIZED SIGNATURES**

A. If anyone other than the registered owner or recognized lessee of a horse is authorized to sign any documents, a notarized authorization form signed by the owner or recognized lessee, giving specific details such as the authorized person's name and address as well as his signature, and the dates involved, must be on file with the ApHC. Authorization forms are available at no charge, upon request, from the ApHC.

B. In cases of persons, partnerships, corporations, businesses and syndicates, a notarized authorization form must be on file listing the person or persons who may sign for that entity and the dates (beginning and ending) involved. The ApHC cannot accept the signatures of anyone other than the registered owner or the lessee as recognized by the ApHC without this authorization. This includes husbands, wives, parents, and children.

C. For a horse covered by a lease, the notice of which has been filed with the ApHC, only the lessee or lessee's authorized agent may sign registration documents.

## **Horse Authorization**

An owner may authorize another person to sign on his/her behalf for specific transactions related to a specific horse during a specified time period. For example, a stallion owner may authorize another person to sign registry documents such as a stallion report and/or registration application during a specified time period. In this case, the recorded owner must specify the stallion in his/her ownership for which another person may be authorized to sign.
