**Scoring:** 0-100 with 70 denoting the average. Maneuvers are scored +11/2 to -11/2 in 1/2 point increments

**GUIDE FOR NEW COW:**

- Cow that won't run
- Cow that doesn't respect horse
- When cow leaves arena

**CREDIT:**

- Maintaining control of cow at all times
- Exhibiting superior cown sense and natural ability without excessive reining or spurring
- Degree of difficulty
- Eye appeal

**1 Point Penalty:**

- A- Loss of working advantage
- P- Working out of position
- C- Changing sides on the second drive/rate
- M- Failure to drive past the middle marker

**3 Point Penalty:**

- D- Failure to drive cow past middle marker on 2nd drive before time expires
- K- Knocking down the cow without having working advantage
- L- Loss of control and cow leaves end of arena
- T- Performing a fence turn

**5 Point Penalty:**

- B- Spurring or hitting in front of cinch or excessively whipping/spurring horse
- C- Blatant disobedience
- X- Running cow into back fence with force

**0 Score:**

- A - Turning tail to cow
- B - Using 2 hands
- C - Fingers between reins
- D - Balking
- E - Extremely out of control
- F - Leaving work arena before pattern or work is completed
- G - Fall of horse/rider
- H - Schooling horse between entering arena and cow work
- I - Schooling horse between cows when new cow is awarded
- J - Disrespect or misconduct
- K - Improper western attire
- M - Judge may DQ horse if fresh blood is found on mouth/body
- N - Judges have sole authority to determine if blood found on the horse warrants DQ from the class
