- Losing cow
- · Changing cattle after commitment
- Failure to separate single cow after leaving herd
- · Blatant disobedience

Off Pattern (OP):

- Turn tail
- Failure to cut 2 cows
- · Repeated blatant disobedience
- · Use of 2 hands
- · More than 1 finger between split reins

Disqualification (DQ):

- Lameness
- · Inhumane treatment
- · Disrespect or misconduct
- · Illegal equipment
- · Excessive disturbance of herd
- Fall of horse/rider
- · Improper western attire
- Leaving arena before run is complete (Exception: has worked 2 head & has option of ending their run before the 2-minute limit)
