



# Ranch Reining Score Sheet

## PATTERN 5

**Scoring:** 0-100 with 70 denoting the average. Maneuvers are scored +1 1/2 to -1 1/2 in 1/2 point increments

**1/2 Point Penalty:**

- Starting circle or exiting rollback at trot for up to 2 strides
- Delayed change of lead by 1 stride where lead change is required
- Failure to remain a minimum of 20' from wall when approaching stop and/or rollback
- Over-spin or under-spin by 1/8 turn

**1 Point Penalty:**

- Out of lead in circles, figure eights or around end of arena
- Over-or under-spin 1/8 to 1/4 turn
- Slipping rein
- Over bridled (per maneuver)
- Out of frame (per maneuver)

**2 Point Penalty:**

- Break of gait
- Freeze-up in spins or rollbacks
- Failure to stop or walk before executing lope departure on trot-in patterns
- Failure to be in lope prior to 1st marker on run-in patterns
- Failure to completely pass marker before initiating a stop
- Trotting beyond strides, but less than 1/2 circle or 1/2 length of arena

**5 Point Penalty:**

- Blatant disobedience
- Use of either hand to instill fear /praise

**Off-Pattern - Cannot place above others who completed pattern correctly:**

- Breaking pattern
- Elimination or inclusion of maneuver (e.g. over-or-under-spinning)
- Backing more than 2 strides
- Repeated blatant disobedience
- Use of 2 hands per maneuver or more than 1 finger between split reins or fingers between romal reins per maneuver
- Trotting more than 1/2 circle or 1/2 length of arena

**Disqualification:**

- Lameness
- Abuse
- Illegal equipment
- Disrespect or misconduct
- Improper western attire
- Fall of horse/rider
- Spurring or hitting horse in front of cinch
- Leaving arena before pattern is complete
