## Recreational Trail Ride Notes

Mileage for Recreational Trail Rides may be earned at ApHC-sponsored and –approved rides only. A separate program (Saddle Log) is available to earn awards for time spent riding your Appaloosa. A separate merit system is in place for events such as Mountain Horse Challenges, Trail Trials, Trail Challenges and similar competitions under the Judged Trail Ride category of the Appaloosa Competitive all-Breed Activities Program (ACAAP).

- The horse must be enrolled in the distance program to earn miles – one-time fee of \$35/horse. After the first year, there is an annual \$10 fee to have results recorded in the horse’s record. This fee should be submitted with the first ride report sent in for the current ride year.
- Both the current recorded owner of the horse and the rider (if different than the owner) must be current ApHC members for mileage to count.
- ApHC Ride Year is December 1 – November 30.
- Ride results must be received by the ApHC within 30 days of the ride in order to track current status of Year-End Award mileage. Absolute deadline is Dec 15.
- Mileage from ApHC-sponsored or –approved recreational trail rides of at least 3 days in length will be applied toward the 400-mil ROM, 800-mile SEA, 1000-mile medallion and Trail Ride Hall of Fame eligibility.
- Mileage from ApHC-sponsored or –approved recreational trail rides shorter than 3 consecutive days will be applied toward the ROM, SEA and medallion. These rides count as half-rides toward Trail Ride Hall of Fame eligibility.
- There is a late fee of \$75/year to correct mileage records from prior years. Mileage added after the completion of the ride year shall not affect any annual or year-end awards earned within that ride year.
