To be eligible for certification into the ApHC SMALL HORSE CERTIFICATE PROGRAM, the applicant horse must first be registered with Pony of the Americas Club, Inc. (POAC) and the applicant owner(s) must be recorded as owner(s) on the POAC certificate of registration copy provided to the ApHC. Horses enrolled in the Small Horse Certificate program may be eligible to participate in ApHC approved shows, trail rides, and other programs offered by the ApHC, as stated in the Official Handbook of the ApHC. **No breeding rights are extended to horses enrolled in the ApHC Small Horse Program under ApHC Rules.** Please refer to the **Official Handbook of the ApHC** for all rules and requirements.

**The following requirements must be submitted by mail to the ApHC:** (An incomplete application may cause delay in processing.)

1. Submit this SMALL HORSE REGISTRATION PROGRAM APPLICATION fully completed and signed by a recorded owner on the POAC Certificate of Registration for the applicant horse. Missing or incomplete information may cause delay in processing this application.
2. Submit a copy of the **front and back** of the Pony Of the Americas Club, Inc. (POAC) Certificate of Registration.
3. Submit four photographs: front, both sides, and rear view, all photos must be in color and clearly show any and all markings (including brands and scars) on the head, body, and all four legs. Write the POAC horse's name and POAC registration number on the back of each picture. **Photographs are not accepted by e-mail.** Photographs must be on photo quality paper and not larger than 4x6 inches (10.2 cm x 15.2 cm). The ApHC reserves the right, at its discretion, to require additional photographs of better quality. Photographs are used for horse identification with the POAC registration papers and will not be reproduced on the Small Horse Certificate Program certificate.

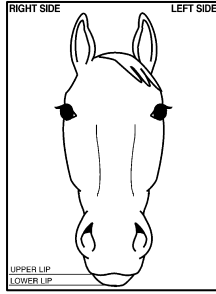

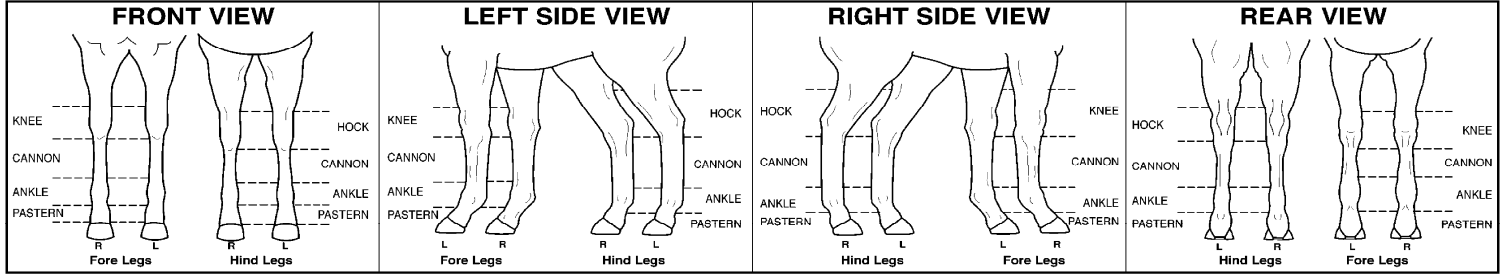
